# Minutes of the April 17, 2018 Special Meeting

Eden called the meeting to order at 6:40 PM.

## 1. Acceptance of Resignation.

On motion duly made and seconded, the resignation of Christy Guzzetta as President was *accepted*.

# 2. Motion to appoint a President.

On being duly made and seconded, and following discussion, a motion to appoint a President was *approved*.

#### 3. Appointment of President.

On motion duly made and seconded, Eden Weiss was *appointed* President of the Club for the balance of 2018.

# 4. Discussion of Civility and Transparency in Club Dealings.

There followed a lengthy discussion of the need for civility and transparency in Club dealings. The events surrounding Christy's resignation were also discussed. Mike Weitzman proposed that Felicia Ennis work with the Board to develop some sort of grievance or complaint procedure to bring cases like this to the Board. This was well-received. Eden also proposed that the Board participate in a workshop on these issues. This too was well received, although discussion of specifics was tabled until the Board's May meeting.

#### 5. Message to the Membership.

Peter distributed a draft of a possible statement to the membership discussing the events leading to Christy's resignation, restating the Club's Policy against harassment,

bullying and similar behavior and stating the Board's continuing opposition to such behaviors. Several edits were agreed on, and the resulting draft was then referred to Felicia Ennis for her thoughts on the document.<sup>1</sup>

## 6. Ratification of the Secretary's Statement on Christy's Resignation.

Peter's April 12th statement on the Message Board and on the Facebook members' page announcing Christy's resignation was *ratified*, and a copy was ordered to be filed with the Minutes.

# 7. Resignation of the Webmaster.

The resignation of the Webmaster as a result of the same events was noted, but not accepted. On motion duly made and seconded, and after discussion, the Board *voted* to ask Jorge Negrin to return to that post.

The meeting then adjourned at 9:05.
